- Not a single passenger will be allowed on the bus till 100% of the balance is covered.
- Deposits are non-refundable in the event of customer cancellation.
- Overtime will be permitted, upon vehicle and driver ability and is not guaranteed. Overtime is billed by the half hourly rate and will be collected at the end of the trip by cash payment. Overtime rates will be equal to the stated hourly charge.
- I have accepted BusTaMove in good faith and agree to the above listed price. I agree to pay for all services rendered at the time of pick up, and any additional hours at the trips end. I understand and agree to the length and usage along with any charges and further agree to pay for any and all damages my party may cause during the rental periods. I also agree to the below BusTaMove Rules and Regulations and will personally explain the rules to the persons of my group. I verify that I have read and received all pages of the contract. By signing this contract, BusTaMove and the Client agrees to all terms and conditions stated in this contract.

Bus Rules

- NO GLASS
- If a passenger should **vomit, urinate** or **any other bodily fluids** in or on the bus, there will be a charge of \$200.00.
- NO confetti, silly string, excess glitter, or excessive feathers. Subject to extra cleaning fee of \$50
- NO climbing on roof of bus, hood of bus.
- DO NOT USE any fire exits unless in an emergency. Back door included.
- The BusTaMove driver and/or employee reserves the right to eject any individual(s) whom they deem to be disruptive, unreasonably intoxicated, to pose a safety threat to themselves or to others, or deemed to be using an illegal substance.
- For any actions such as fighting, violence, damage to equipment and/or bus, or harassment toward the driver, staff or anyone else in or around BusTaMove Party Bus, the driver reserves the right to terminate the trip. The client will be responsible to find other transportation and forfeits full fare as a result.
- BusTaMove is not responsible for any lost or stolen articles during the ride or articles left after the ride has ended.
- Alcoholic beverages are not allowed outside of the bus during the trip. • BusTaMove is not responsible for underage consumption of alcoholic beverages at any time before, during, or after the ride. Driver has the right to inspect ID's and containers of passengers who appear to be underage.
- By signing up and participating in the ride, the individual agrees the BusTaMove Party Bus and it's employees are not responsible for any claims of injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.
- By signing this contract, the above client agrees to assume full responsibility for any damages to the interior or exterior of the bus that is caused by any individual riding the bus. The client is liable for the cost to repair any such damage as well as any cost for loss of BusTaMove service due to such damage.
- BusTaMove is not responsible for injuries or accidents in and around the bus. Alcohol impairs motor skills, balance and judgment. Clients are asked to remain seated while the bus is in motion. Move about at your own risk. Please use caution on the steps.
- BusTaMove is **NOT LIABLE** in case of unexpected vehicle breakdowns, accidents, severe weather or anything that may delay arrival or cause cancellation of the trip. In the event of a cancellation due to mechanical problems, the trip may be rescheduled for another date or refunded in full. Client will be notified as soon as possible to let them know of unexpected problems that may postpone trip times. BusTaMove will do whatever it takes to get backup transportation.
